2. J-DRain will not deteriorate or decompose to a point of failure if installed in accordance with JDR's standards for a period of one year from the date of application.

In the event the PRODUCT fails to be warranted in paragraph (1) or fails to perform as warranted in paragraph two (2), JDR's obligation is limited to the replacement of the PRODUCT, including freight cost, or repayment of the sum equal to the amount of the original purchase price of the material.

If at any time during such one (1) year period the J-DRain does not perform as warranted above, then JDR Enterprises, Inc. will supply replacement J-DRain in exchange for and to the extent that J-DRain is found by JDR Enterprises, Inc. not to comply with this warranty.

This warranty does not apply to any J-DRain product unless installed and maintained to conformance with the printed instructions of JDR Enterprises, Inc. from time to time in effect. Further, this warranty does not cover damage caused by abuse or abnormal use of the J-DRain, acts of God, inadequate or faulty design of the subject building and to repairs or installations made by persons not approved by JDR Enterprises, Inc.

The foregoing warranty is exclusive and is in lieu of any and all guarantees or warranties, express or implied, including without limitation the implied warranty of merchantability and fitness for a particular purpose. The remedies of the buyer for any breach of this warranty shall be limited to those herein provided to the exclusion of any and all other remedies, including without limitation incidental or consequential damage. JDR Enterprises, Inc. shall not be liable in any case for any damage to the building or the contents thereof. No agreement varying or extending the foregoing warranty remedies will be binding upon JDR Enterprises, Inc. unless in writing, signed by a duly authorized officer of JDR Enterprises, Inc.
